Meetings

The Annual Meeting was held on May 15th, 2014 at Baker & McKenzie Law Offices at which 16 members entitled to vote participated.

In addition to the Annual Meeting, the Board held 5 meetings during the year at which Minutes were taken, in addition to several informal working group meetings.

Activities during 2014

The purpose of our Club is to provide a professional and social network for all Harvard alumni with a link to Sweden, to stimulate and encourage intellectual curiosity, as well as to help alumni maintain and strengthen their connection to Harvard. During its eighth active year since its founding in 2007, Club activities focused on arranging interesting events and recruiting new members, including current students and scholars at Harvard.

By the end of 2014, the Club had recruited more than 180 members. The Club's Student Chapter for current students and scholars at Harvard (founded in 2010), also continues to grow and regularly arranges events in Cambridge.

The Club's website at the <u>www.harvardclub.se</u> address is the main channel for information about the events and activities, but the LinkedIn and Facebook groups (including a Facebook group for current students and scholars at Harvard) complement the home page in reaching existing as well as potential Club members.

The Harvard Club of Sweden is actively engaged in maintaing as well as fostering new ties with Harvard University. The Harvard Book Prize Program has been an important way for Harvard Club members to actively participate in attracting talented young people to Harvard. A Book Prize may be awarded to outstanding students in the next to graduating class in Swedish high schools/gymnasium who demonstrate excellence in scholarship and an additional area.

The Harvard Club of Sweden is also responsible for offering alumni interviews to Swedish high school students applying to Harvard College.

These two programs allow alumni to serve as ambassadors for Harvard to young Swedes, thereby offering them first hand contact with the Harvard experience.

Furthermore, several events were arranged by the Club during the year 2014, e.g.;
